Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 191.7 tCO_2e by 2027. This is a reduction of 60%.



Carbon Reduction Projects

In the future we hope to implement further measures such as:

The introduction of LED lighting throughout our facilities, replace our Gas heating system with highly efficient heat pumps, install push taps to reduce water consumption. Moreover, we will implement an electric car salary sacrifice and cycle to work scheme to encourage our employees to switch to low-carbon transportation options.
